

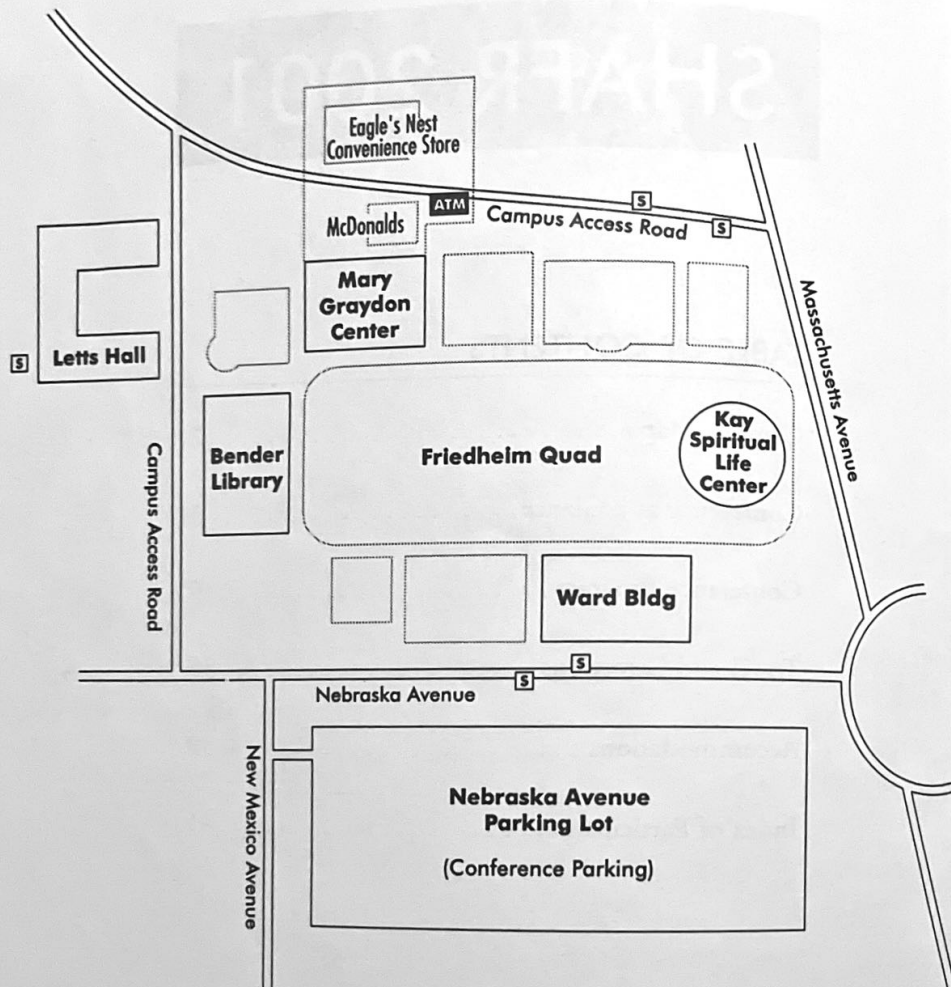

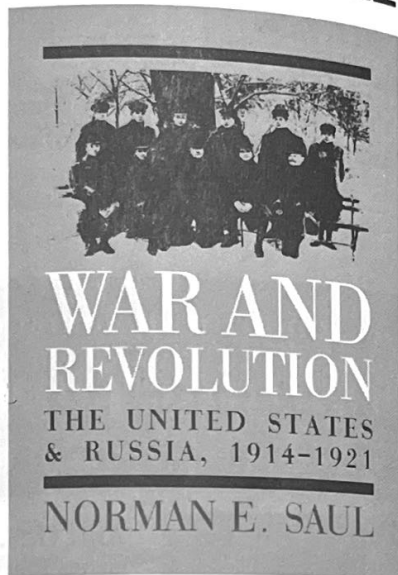

AHA Launches Study of Graduate Education

Over the course of the past half century the historical profession has changed in profound and important ways—in numbers of historians, the social composition of the profession, employment opportunities, the diversity of work-settings of historians, levels of specialization and professional identities, the place of history in American public life and in the liberal arts curriculum of high schools and colleges, and, most important of all, in its intellectual content, including a vast expansion of the subject matter of history. All of these changes have implications for the training of future historians, and it is the responsibility of professional associations to explore these implications.

The AHA Council has created a Committee on Graduate Education (CGE), chaired by Colin Palmer of Princeton University and the AHA's CGE Research Director, Phil Katz, to undertake on behalf of the association an examination of doctoral training in history. The Carnegie Corporation of New York has provided substantial resources to support this multiyear self-study. The committee has three general objectives: first, to undertake a critical assessment of the current state of history graduate training by examining pedagogical practices and methods in a variety of programs; second, to consider and make recommendations on ways to improve graduate training in several areas, including teaching training, cross-disciplinary studies, the use and training of a history master's degree, and public history programs; and third, to make recommendations regarding the future direction of graduate education in history.

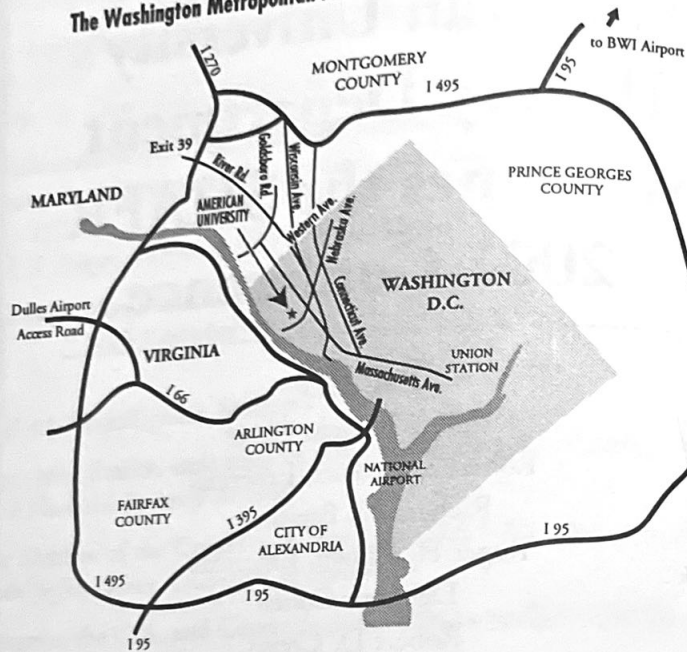

TRAVEL AND DIRECTIONS

The Washington Metropolitan Area



BY AIR

The Washington, D.C., region is served by three airports: Reagan Washington National (D.C.), Dulles International (Va.), and Baltimore-Washington International (Md.).

BY TRAIN

Washington, D.C., is served by Amtrak. Trains arrive at Union Station (on Metro's Red Line).

BY CAR

American University is located on Ward Circle, at the intersection of Massachusetts and Nebraska Avenues, N.W., in Washington, D.C.

From northeast of Washington (New York, Philadelphia, Baltimore), follow Interstate 95 south to Interstate 495 west toward Silver Spring. See from Interstate 495 (Capital Beltway).

From south or west of Washington (Norfolk, Richmond, Charlottesville) follow Interstate 95 north or Interstate 66 east to Interstate 495, the Capital Beltway. Follow Interstate 495 north. See from Interstate 495 (Capital Beltway).

From northwest of Washington (western Pennsylvania, western Maryland), follow Interstate 270 south. Where Interstate 270 divides, follow the right-hand branch toward northern Virginia. Merge with Interstate 495, the Capital Beltway, and soon afterwards take exit 39, River Road. See from Interstate 495 (Capital Beltway).

From Interstate 495 (Capital Beltway), take exit 39 and carefully follow the signs for River Road (Maryland Route 190) east toward Washington. Continue east on River Road to the fifth traffic light. Turn right onto Goldsboro Road (Maryland Route 614). At the first traffic light, turn left onto Massachusetts Avenue (Maryland Route 396). Continue on Massachusetts Avenue for about two miles, through the first traffic circle (Westmoreland Circle). About one mile further on, enter a second traffic circle (Ward Circle). Take the first right turn out of the circle, onto Nebraska Avenue. The campus is on your right.

BY METRO

Washington's Metro trains run during the following hours:

The closest Metro stop to American University is Tenleytown-AU (also called Tenley Circle) on the Red Line. Shuttle buses run from Tenleytown-AU to American University on a regular basis. (Exit station to east side of Wisconsin Avenue; shuttle stop next to Metro bus stop and Hollywood Video.) PARKING

Free parking for all participants will be available at American University during the conference in the Nebraska Avenue lot. Enter from New Mexico Avenue.

ACCOMMODATIONS

ON-CAMPUS ACCOMMODATIONS

SHAFR participants choosing to stay on campus will be housed in Letts Hall, across the quad from the Ward Building, where most of the conference will be held. Rooms at Letts are \$74.00 per night for a single room and \$37.00 per night for doubles, not including sales tax. Parking, at no additional charge, is available in the Nebraska Avenue parking lot.

Letts is a traditional residence hall with communal bathrooms (one for men and one for women on each hallway). All rooms are fully air-conditioned with in-room controls, and there are laundry and kitchen facilities on each floor.
